

PRIVACY POLICY

I. INTRODUCTION

As Akademi Turizm ve Organizasyon Ticaret A.Ş. (“**ForteMedcare**”), we value your privacy and the security of your data. Therefore, this Privacy Policy has been prepared to inform you about what data we collect, the purposes of data collection and your rights regarding your data. The Privacy Policy applies to www.fortemedcare.com (“our website”). If you do not accept this Privacy Policy, you should not continue to use our website.

II. COLLECTED DATA

Through our website, during the application for information, requests and complaints regarding the services we provide, or during the use of the website, you submit your **Identity** (name, surname, username), **Contact** (e-mail address, phone number), **Transaction Security Information** (IP Address, Online Identifiers) and **Customer Transaction** (subject, complaint, request information) information to ForteMedcare.

You submit your Identity and Contact information to ForteMedcare by filling out a form on our website so that our customer support team can contact you regarding our services.

From the moment you start using our website, we collect information on your transaction security IP address, web pages you visit, internet login and logout information, browser information, access status, your preferred language, operating system name and version, and your time and date information of these activities; to improve the visitor experience, to prevent and investigate fraudulent or unauthorized activities and/or to support our marketing activities.

III. HOW DO WE USE THE DATA WE COLLECT?

We use the data you provide directly to us for the purposes of establishing and maintaining your application process, making use of the features on our website and providing information on the provision of services.

These uses are carried out based on the provisions explicitly stated in the law, the establishment and performance of a contract, the necessity for us to comply with our legal obligations, the necessity of data processing for our legitimate interests.

Your IP address is collected and stored in order to fulfill our legal obligation arising from the Law No. 5651 on the Regulation of Internet Broadcasts and Prevention of Crimes Committed Through Such Broadcasts.

IV. FOR HOW LONG DO WE STORE YOUR DATA?

Your Personal Data will be processed and stored for a limited period of time in accordance with **ForteMedcare's** Storage and Destruction Policy. In the event the legal grounds requiring data processing no longer apply, your data will be deleted, destroyed or anonymized ex officio or upon your request. In this context, you can review our Personal Data Storage and Destruction Policy prepared by our company.

V. SHARING YOUR DATA WITH THIRD PARTIES

Your data is not sold to third parties for any commercial reason or in exchange for money. In this context, we do not share your data with third parties, except for requests from Authorized Public Institutions and Organizations, in order to fulfill our legal obligations.

VI. COOKIES

Cookies are small data storage files that are saved on your accessed computer, mobile phones, tablets or other mobile devices by websites.

This file stores information about your navigation on the Website. Thus, the devices you access will remember this data when you use the Website again. Therefore, cookies are necessary and important for you to use the Website effectively and more easily.

IX. YOUR RIGHTS REGARDING YOUR PERSONAL DATA

- to object to the occurrence of a result against the person himself/herself by analyzing the data processed solely through automated systems,
- to claim compensation for the damage arising from the unlawful processing of his/her personal data.
